CHAIR'S REPORT: David Thomas

Thomas called the first meeting of 2014-2015 to order at 3:15 p.m. and welcomed everyone.

Thomas introduced himself and committee chairs, and thanked the chairs for serving. He asked the Council members to introduced themselves.

Thomas introduced the OIT team working on OCEAN 2.0. Ilya Kogan, Team Lead for Custom Applications, updated the Council on what is happening with OCEAN. Ilya introduced Jackie Barr, the project manager, Davin Simmons, and Michael Dixon, developers. OCEAN 2.0 is concentrating on courses at start up with programs to be added later. Ilya asked for input on what people did not like about OCEAN. Some suggestions: Simplification of information regarding changes within courses and programs in OCEAN, intuitive screens, ability to maintain visibility of distinct difference within documents, active and archive work list, map a workflow, designate distribution areas in Arts and Sciences. Ilya asked the Council members to send input on OCEAN 2.0 to Sally Marinellie or Laura Tuck.

Thomas asked for approval of the April 8, 2014 minutes. Kruse moved. Tuck seconded. Motion carried. Minutes approved.

Thomas explained that the Friday Group was a task force that was created to kick around ideas to bring to UCC during Q2S, to see problems before they became problems and to oversee disputes between departments over ownership of courses and programs. Friday Group met to discuss several items: Innovation Strategy, Certificates and Service Learning and General Education.

Thomas asked the Council to give Sally Marinellie feedback on the Guidelines for Individual Course Committee that are currently posted on the ICC website.

Thomas asked the Council that during the 2014-2015 Academic Year to be sensible when asking for a waiving of readings.

PROGRAMS REVIEW COMMITTIEE: David Ingram, Chair

Ingram reported that a number of self studies have come in. Several have asked for extensions. Media Arts and Studies and one from Higher Regional Education are still outstanding. Reviews are being done on College of Business, Heritage College of Osteopathic Medicine, most of the College of Communication, 1/3 of the College of Arts and Sciences, and many Regional Higher Education programs.

There are reviews from last year that are at the Graduate Council level and should be coming through this year as well.

INDIVIDUAL COURSE COMMITTEE: Sally Marinellie, Chair

Marinellie informed the Council that this is the first time there is a co-chair of ICC who is Mary Rogus. Mary is managing all course changes so any questions regarding changes should be directed to her. Sally will manage new courses.

The new guidelines are posted on the website. Marinellie asked for feedback on the document.

The committee reviewed 67 new courses and approved 49 of those courses for a 73% approval rate. The committee also reviewed 47 course changes and approved 26 of the changes for a 55% approval rate. One of the reasons for a lower approval rate in course change is due to the actual change and the reason is not explicit on the course which will cause them to be returned.

Marinellie presented the ICC minutes appended to this report
Marinellie added CLWR 2230, PA 5540 and 5552 which were approved after the ICC meeting.
A concern was raised regarding the prerequisite change for CHEM 1210. MATH D005 was added but not MATH D004 which is equivalent to D005 but is a regional course only. The course was pulled from the minutes for further discussion.

Program Name: Sport Management

Summary Statement:

Propose changing the degree name from Bachelor of Science in Sport Management to Bachelor of Sport Management. The change of degree name to Bachelor of Sport Management (BSM) has a number of key advantages for both our program and our students/alumni. First, it clarifies that this is a business degree, but with an industry focus on sport. Currently, we receive feedback from alumni that employers are often confused by the inclusion of "Science" in degree name, which is a term rarely used in other sport degree names. This confusion over the degree name has led to questions in interviews or (perceived) failure to get to the interview process. Second, as the Department of Sport Management (DSA) embarks on a growth phase to include partnerships with global universities, the differentiated BSM degree allows us to pursue dual degrees with BBA programs around the world. Third, the BSM degree fits nicely with our world-ranked MSA (Master of Sports Administration) degree as clear management of sport degrees. Fourth, the BSM degree positions the undergraduate degree as a business degree within the College of Business but with the industry-focused distinction it needs.

Program Name: Law, Justice, & Culture Certificate **Contact/Designee:** Haley Duschinski; duschins@ohio.edu

Summary Statement:

The Certificate Program in Law, Justice & Culture is an interdisciplinary curriculum providing students with opportunities to study law in relation to society, culture, politics and power, from an integrated liberal arts perspective. Students in this selective certificate program currently take 3 required courses as well as 9 additional elective credit hours from a list of 24 courses. Of these 24 courses, 8 are Sociology and 10 are Political Science. We are requesting approval to add 7 new courses to the elective list and to remove 1 course. The new course additions are all established courses that approach law from a "constitutive" liberal arts perspective, which means that they seek to analyze and interpret law, not as a professional instrument or taken-for-granted institution, but rather as a conceptual framework and form of practice that is socially constructed, historically contingent, and culturally produced. The new course additions come from an array of departmental and disciplinary perspectives, thereby diversifying the range of academic viewpoints available to students. We anticipate that this will attract a broader range of certificate students from various majors to the certificate program. Students will still take 9 hours of elective credit hours from a longer list of course offerings. We do not anticipate any substantial impact on any particular course or department, since the certificate program is restricted in size to no more than 25 students per year. We are also requesting the removal of a particular Political Science course that focuses primarily on politics rather than law.

Proposed new courses include the following: SOC 4710, HIST 4536, AAS 3691, AAS 3692, T3 4070, ENG 3570, HIST 3270. The course that will be dropped is POLS 4015.

Summary Statement:

The Screenwriting and Digital Storytelling Minor in the School of Media Arts and Studies (MDIA) is designed for individuals majoring in other fields who wish, in the course of their college experience, to gain an understanding of digital storytelling techniques, including the process of writing stories for the digital screen (i.e. television, video or game screen). With digital media becoming ubiquitous in our society, the ability to analyze and deliver digital stories will better prepare students for both work and graduate education in a wide variety of fields not only in the entertainment industries, but in other areas such as business and healthcare. The addition of this minor supports the vision of the School of Media Arts & Studies (MDIA) and the Scripps College of Communication and was approved by the MDIA faculty after careful review. We do not believe that it conflicts with any other undergraduate department or school at Ohio University, as we are not adding any new courses to our program. We are simply organizing the courses to provide continuity to students who want to explore this field in a more coordinated manner.

Summary

We propose to add 11 Economics electives to the list of 13 Economics electives now shown in the program. Students will continue to choose 6 classes from the list so there will be no impact on total program hours or resource requirements. Our rationale for adding more classes to the list is that doing so will provide students with more flexibility in scheduling while still maintaining the program's emphasis on electives which have a high degree of quantitative and analytical material. More flexibility is needed because 9 of the electives currently on the list of 13 are only

offered once a year or every other year. Thus students find it difficult to enroll in 6 electives and still graduate in 4 years.
