Currently, a school nurse licensure program exists at Ohio University, and it has been offered collaboratively between the School of Nursing and the Patton College of Education for more than five years. Recent legislation has resulted in changes in the school nurse education

requirements, necessitating a reduction in total credit hours and in clinical practicum hours. The credit hour requirements and content needed to be updated to meet current Ohio Department of Education standards. The Ohio University current program requires 41 credit hours, whereas other School Nurse programs in the state average 13-18 credit hours. Thus, we are proposing the new school nurse program to be an interdisciplinary undergraduate certificate of 15 credit hours. Individuals who wish to work as a school nurse must complete an approved school nurse program and request a pupil services license from the Ohio Department of Education (ODE) in order to work in Ohio schools. There are no anticipated additional space requirements or faculty positions needed to support this program. Faculty will teach the courses as part of the traditional BSN or RN-to-BSN programs. Courses in this specialty certification may also be taken by BSN prepared Registered Nurses.

Upon reaccreditation inspection by the Forensic Science Education Programs Accreditation Commission (FEPAC), several curriculum issues were identified making the program noncompliant with FEPAC standards. The changes proposed are to address these issues. Changes are as follows:

- 1. Remove Tox/Trace and DNA Analyst tracks from the curriculum. Rationale: For our current Tox/Trace track, FEPAC did not approve BIOS 2060 as it was not 3000 level or above and ANTH 4470 is taught too infrequently. FEPAC also did not agree with the names of the tracks and felt they were misleading.
- 2. Make UC 1900 a required course. ("Forensic Chemistry LC" designation). Rationale: FEPAC requires a freshman "seminar" course. Impact on total program hours: This will add 1 credit hour to the major.
- 3. Make LET 4900 a required course. (Will be submitted to UCC as new course.) Rationale: FEPAC requires a Forensic Science Capstone experience for graduating seniors. Impact on total program hours: This will add 3 credit hours to the major.
- 4. Make CHEM 49XX (Will be submitted to UCC as new course), BIOS 3100, and BIOS 3105 required courses Rationale: This will bring the total credit hours in the students' area of specialization to 21 in compliance with the minimum of 19 required by FEPAC. Impact on total program hours: This will only add 3 credit-hour to the major, as BIOS 3100 and 3105 were already required for one of the tracks. As all of these courses are already offered, there are no changes to the requirements for resources or faculty and no other department is affected.

1. Reclassification of Language Requirement: The program wishes to reclassify the language requirement from requiring students to complete the equivalent of two years of study in one of the specified languages relevant to the area of historical concentration (AKAN, ARAB, HIND, INDO, or SWAH) to it being an option to fulfill as one of the electives requirement of the certificate. This will help with enrollment as well as attend to uncertainties with the languages listed in the certificate.

2. Addition of new courses/removal of courses no longer offered. I also wish to update the list of courses that count toward the various requirement areas. The full listings are located in OCEAN.

Neither the reclassification of the language requirement nor the course update affects the total requisite number of hours for the certificate or make any new demands on the relevant departments.

These changes are based on lessons learned as students complete the program, a program review with advisory board members, and the desire to improve the path to professional licensure for our graduates. These changes (and the change to technical elective structure) also make it easier for students to pursue a project management certificate, which our advisory board recommends.

- 1. Math and basic science requirement: Geology for Engineers GEOL 2830 is a more relevant math and basic science course for some of our students than the current CHEM 1520, so we will create a 'select from' category that allows either course to fulfil the science elective. Both classes are 4 hours with a lab, so there is no change to total hours.
- 2. Fundamental requirements: Three engineering fundamental courses (ET 2200, ET 2220, ET 2240) are added to improve career options and prepare students to take the FE exam (the 1st step to professional engineering licensure). [+ 9 hours]
- 3. Core requirements: Two courses that were more specific to certain energy specialties (EnE 3400 Fuels Conversions (4 cr) and ME 4230 Fuel Cells (3 cr)) are changed from required to elective courses to allow for the fundamental course additions without significantly increasing total hours. Also, based on our experiences with EnE projects our year-long capstone design is being changed to a one semester project management course (ISE 4490 (2 cr)) followed by a one semester capstone design course (EnE 4100 (4 cr)). EnE 4110 is removed (4 cr). This change fully balances out the addition of core requirements so there is no net increase in hours. [– 9 hours]
- 4. Technical Electives: We are modifying technical electives to allow interested students an easier path to obtain a project management certificate in addition to the EnE degree, with only 3 additional credit hours than the standard path.

The current path (without the certificate) still remains with no increase in credit hours.

The Dance Division would like to make a few key changes to the Dance Performance and Choreography minor to make it possible for more students to complete. In its current configuration, this minor requires that thirteen credit hours must be taken as a block in two consecutive semesters during one academic year. The proposed changes include: allowing a greater range of course options, including a few non-major dance courses for those with less prior training; adding one course with an emphasis on global dance traditions and making it possible to use other global dance courses as electives for this minor; reducing the overall required credit hours from 20 to 18; and replacing the audition with a placement class that can be taken after preliminary coursework has been completed. The new African Dance Technique requirement and the greater flexibility with elective courses will update this program in terms of global perspectives and bring it into line with our current major programs and departmental outlook. These changes will not have any impact on resources or faculty, as all of the required courses are currently offered.

The goals for these proposed changes are to increase student satisfaction with the Studio Art minor and to increase interest in the minor. Enrollments in MATH 3200 are very strong, but sparse in MATH 3210. In the future we might not be able to offer MATH 3210 every semester. Allowing the option (MATH 3200 or 3210) will allow more flexible scheduling for our students and for our staff. This does not change total program hours. It does not affect any patron departments. It will potentially allow for more efficient use of faculty and other resources.
