Ferriell teaches contracts, secured transactions, business bankruptcy, and consumer bankruptcy at Capital University Law School. Before coming to Capital, Ferriell was a Professor of Law at Ohio Northern University. He has been a Visiting Professor at Santa Clara, San Diego, Seattle University, and Ohio State, and a law teaching fellow at Illinois. His areas of research are contracts, bankruptcy, and the uniform commercial code. He is the co-author of two law school hornbooks: *Understanding Contracts* (second edition 2010) and *Understanding Bankruptcy* (second edition 2007, with Edward J. Janger). He serves as Ohio's representative to the National Conference of Commissioners on Uniform State Laws (or "Uniform Law Commission"). In 2016, he was named the Geraldine W. Howell Professor of Law at Capital.
